- Kosovo is in the middle of the Southeastern Europe. Having occupied the central position in the Balkan Peninsula, Kosovo represents important connection between Central and South Europe, Adriatic Sea, and Black Sea.
 - Surface of Kosovo is 10,908.1 km².
- The climate in Kosovo is middle continental with hot summer and cold winter.
- Kosovo has about 2 million inhabitants. Its density is about 193 people per km², and is divided into 33 municipalities.
- Capital of Kosovo is Pristina.










Three major Issues in Mainstreaming gender in my Country

- 3. Employment of minority women






Position in the national gender machinery and job descriptions

- b. Assist in the development and implementation of publike information campaigns and other promotional schemes to promote public awareness of international minority and equal opportunities standards.






Issue(s) to be addressed in mainstreaming gender:


Minorities are often discriminated where are living. Being female and minority will be said twice discriminated. The position of minority women is difficult as they are discriminated twice in every part of life.






Justification for choosing the above issue


Activities in the action plan aimed at facilitating the plight of minority women through recognizing their rights to strengthened in society
