



2-Basic information on federal republic of Nepal


Nepal is a federal republic that is landlocked and situated in south Asia between China in the north and India in the south. it is a multiparty democracy headed by constitutional president administered by a prime minister at the national level with a Constitutional Assembly of 601 elected members and a local government system which is at present supervised by the Ministry of local development.

By a Local Self Governance Act in 1999 to build on and improve the existing legislative framework for decentralization within the board democratic environment. the LSGA was enacted to enhance participation of people, including ethnic communities, indigenous people and the downtrodden socio-economic backward groups to raise social ethnicity and distribution of development.

The Syangja District which has 2 Municipalities and 60 Village Development Committee is one such decentralized entities. It covers an area of 1164 square kilo meter on an altitude of 366 meter and a population of 3, 17, 320 people made up of 1, 73, 701 females and 1, 43, 619 males.

Nepal has a population of about 27.1 million that is made up of 103 ethnic groups, 59 indigenous Castes, 93 spoken languages, diverse culture and life style in 75 Districts, 58 Municipalities and 3,913 Village Development committees. It covers an area of 1,47,181squaremeter. More than 70% of this population work in Agriculture.







Rising Awareness, Knowledge and idea sharing program In All Parties mechanism In Syangja District Level.

6-Justification for choosing the above issue(s):

In Syangja District level in Nepal, parties mechanism do not make sufficient Gender responsive planning or open up opportunities for the participation of vulnerable and other marginalized or target groups in the planning process to enable them establish ownership. we have some points of difficulties in local level, so I would like to sensitize them in following points. -

-All parties mechanism do not make sufficient Gender responsive plan.

- -All party mechanism and other marginal groups are not make sufficient common concept and gender sensitization each other.
- -Bottom up planning process like follow up and monitoring process also cannot build gender responsive or ownership
- All party have co-coordinating and inclusive power from district level to local level.
- -Mainly they involve on bottom up planning process and district level budgeting..

- -But number of participation rate of vulnerable groups on planning process is low.
- After this programmes they enforced on women and ethnic, marginalized grouped like dalit, janajati, muslim , madhesi and others in bottom up planning.

7-Useful knowledge and skills gained through this program in order to take action against the above issue(s) -

In the course of this training in Japan, I learnt lessons in participatory cycle management in Gender Mainstreaming and realized that in order to achieve a wholly socially inclusive development and promote Gender Equality in the Syangja District, there is a need to raise awareness amongst the parties and all stakeholders /vulnerable, marginalized or target groups etc, and share knowledge and experience in the bottom up planning process on all parties mechanism.
